Minimum Course Load	Due to visa regulations, the minimum course load required for international exchange students is 9 credits. The average course load for students is 12 credits. Students must also take enough credits to satisfy requirements from their home university.

	Admissions
Application deadlines for UConn Law	Applications are considered on a rolling basis. All international student applications should generally be received by May 1 st for Fall enrollment or October 15 th for Spring enrollment. Applications received before these dates will be given priority consideration.
Application procedure for exchange students	Once the students have been nominated by the home institution, a welcome email will be sent to the students with the application instructions.
Fees and Tuition for exchange students	Program fees are paid at the student's home institution. Other fees (such as parking and printer) have to be paid to UCONN Law.

Language Requirements for Exchange Students

UConn School of Law requires one of the following tests to assess English language proficiency:

TOEFL: If taking the TOEFL exam, students must achieve a minimum score of 80 (internet-based).

IELTS: If taking the IELTS exam, students must achieve a minimum score of 6.5.

Cambridge English: Advanced (CAE): The level required is C1 or better.

Pearson Test of English (PTE): The student must score within or above the range of 64 or higher.

The student may be exempt from submitting a TOEFL, IELTS, CAE or PTE if:

- The student is earning a degree from a recognized institution of higher learning at which the primary language of instruction is English.
- Has earned a proficiency certificate from UCAELI (University of Connecticut American English Language Institute) [or the English Language classes offered at UConn Law with pre-approval of the International Programs department].
- The student's native language is English.

Exchange to LLM Transfer

Former exchange students accepted to the U.S. Legal Studies LL.M. Program may be eligible to apply up to 12 credits previously earned while on international exchange at UConn Law toward the 24 credits needed for the LL.M. degree, subject to the following conditions:

- The student must have completed the first law degree at the home institution.
- The exchange student must have applied to the LL.M. program no later than five years after the end of the student's exchange study.
- The Director of International Programs, in consultation with the Director of Graduate & Exchange Programs, shall determine the precise number of transferable credits.
- A former exchange student who transfers into the LL.M. program will not be eligible to apply for the "LL.M. to J.D. program."
