



Second awarding decision of Erasmus+ International call for applications for students and staff mobility 2019 between UPF and partner universities and decision of transferring awarded beneficiaries from Erasmus+ project 2018-1-ES01-KA107-049470 to the Erasmus+ project 2019-1-ES01-KA107-063586

Having reviewed and assessed the applications submitted until 12th April 2021, under the call for applications for students and staff mobility between UPF and partner universities 2019 published on 17th December 2019 and its first awarding decision published on 14th October 2020,

And taking into consideration the proposal by the Selection Committee, on 10th May 2021, which is in compliance with the provisions of the Erasmus+ Programme,

Given the global health situation caused by the Covid-19 pandemic that forced to cancel or to postpone sine die some of the awarded staff international mobility of the Erasmus+ International call for applications between UPF and partner universities in Lebanon 2018-2020;

Given that the Erasmus+ International Credit Mobility Programme Call 2019, linked to the project 2019-1-ES01-KA107-063586, is currently open for applications and there are available for staff mobility to be fulfilled until July 2022;

And according to the guidelines of the call aforementioned, and the internal regulations of the Pompeu Fabra University

I RESOLVE:

2. To transfer to the project 2019, the **2 beneficiaries** selected for staff mobility under project 2018 whose mobility could not take place due to cause of force majeure, providing they are still eligible according to the aforementioned call.
