1. Research path and achievements

BRIEF RESEARCH PATHS:

Throughout my entire career I have been working three main fields within migration studies: *Borders and Human Mobility*: Transnational Diaspora and Entrepreneurship – Externalization of EU migration policies, Intra-EU mobility and EU citizenship - Ethics of migration and human security /// *Diversity and Citizenship*: Intercultural citizenship – Cultural Policies - Multiple and intersectional diversity, Political Parties - Multi-level governance, Urban Governance - Policy narratives and Xenophobic political discourses /// *Methodology in Migration Studies*: Qualitative and Conceptual Research, Research Ethics. I am now working an edited book entitle *How to do Migration Research* (contract signed with Edward-Elgar publishing), with contributors from Canada, United States Europe and Australia

FOCUSED RESEARCH LINE: I identify myself as an inter-disciplinary scholar specialising in migration studies, with a particular focus on urban governance and the Mediterranean area, who methodologically combines empirical and normative analysis (applied political theory). In recent years and with the critical aim of bypassing hegemonic nation-based methodological approaches, I have embraced the “local turn” in migration studies, which implies multi-scalar thinking of migration governance. The basic impact involves both an epistemological and a political turn, and engages many disciplines and areas of expertise, including political geography, international relations, sociology, and urban politics.

Within these lines of inquiry, I have framed inter-related avenues of research: the place of interculturalism as a city approach to diversity governance, the place of Mediterranean cities within the Euro-Mediterranean agenda and how cities contribute to decentralising migration governance in the Mediterranean. Previously, I promoted the *Routledge Handbook on the Governance of Migration and Diversity in Cities* (2019). More recently, I am exploring a new avenue of research that brings urban politics into conversation with migration governance and shaping this research framework within the category of urban resilience. This has been the central activity during my Distinguished Visiting Award at the Graduate Center CUNY (January–June 2022); enabling me to critically engage with American literature, and comparative analysis. My research findings and international collaborations (in Europe, North America and the Mediterranean area) have led to my current concern for linking urban studies and migration studies, which is becoming a pressing issue.

Composition of 19 Members in the Steering Committee. CURRENT RESEARCH INTERESTS

- 1) Develop a new Research Program on *Urban Migration Governance Capacities*. I was awarded an Advanced Research Collaborative (ARC) Distinguished Visiting Scholarship at The Graduate Center of The City University of New York (CUNY) for six months (January-June 2022) under the main topic: Urban Resilience and Urban Migration Governance. Now I will begin a project BROAD-ER (“Bridging the Migration and Urban Studies Nexus”) awarded under the call HORIZON-WIDERA-2021-ACCESS-03 (Twining). Apart from GRITIM-UPF, it includes two more partners: Universiteit van Amsterdam (Netherlands) and Koç University (Turkey)
- 2) Further elaborate on the paradigm of intercultural citizenship, but with more emphasis on the proximity urban governance it implies. I am now interested in exploring how the national and regional / social and political context may influence implementation and outcomes. Also, I work on a pluralistic view of diversity politics and complementarities of different normative policy paradigms, especially multiculturalism (state level) and interculturalism (local level), cosmopolitanism and transnationalism.
- 3) The Mediterranean region is a context of growing connections between cities (networks of cities, external relations and diplomatic partnerships, cities and civil society organizations working in the Mediterranean) that I am exploring, promoting south/east/north comparisons.

2. The 10 most relevant scientific publications

The selection follows the criteria of showing precedents for the main categories of analysis, methodologies and research areas that I am still working. Some are recently published pilot studies showing the potentialities of the category of urban resilience and its impacts, research on multi-level governance, qualitative methodology, urban local governance, trans-national migration, conceptual thinking and Mediterranean migration research (including fieldwork in Tunisia and Morocco) and intercultural policies.

This publication sets the premises of my current research program.
