## PREFACE

This report summarizes the activities of the Department of Economics and Business at UPF during 2007.

Our Department has a teaching staff of 363, with 94 full-time professors and ten administrative staff.

During 2007, we reached several important objectives. First of all, our Department was very successful in the competition for the European Research Council (ERC) Starting Grants for young researchers.

There were more than 9,000 applications and the ERC gave only 300 grants, of which 15 were for Economics, Demography and Geography. Four of the prize winners in this category are related with our Department: Antoni Calvó and Nicola Pavoni earned their PhDs at our Department; Marta Reynal Querol is a "Ramón y Cajal" Research Fellow in our Department; and Jan Eeckhout, an Associate Professor of the University of Pennsylvania, recently accepted an offer from our Department.

Secondly, during 2007, one third of our faculty obtained a Research Fellowship of some kind (Juan de la Cierva, Ramón y Cajal or ICREA), which allows them to reduce their teaching time in different proportions.

Thirdly, this year saw the beginning of Master's courses in collaboration with the Barcelona Graduate School of Economics, a joint initiative between the Department of Economics and Business at UPF, the Department of Economics of the UAB, CREI and the IAE-CSIC.

In terms of scientific publications, our Department continues the trend described in the last report of the ISI Essential Science Indicators for Economics, which pointed out that the Department of Economics and Business at Universitat Pompeu Fabra had achieved the highest percent increase in total citations in the field of Economics and Business.

## INTRODUCCIÓ

Aquest informe resumeix les activitats de recerca del Departament d'Economia i Empresa (DEE) de la UPF durant l'any 2007.

El nostre departament té un professorat de 363 persones, amb 94 professors a jornada completa i un equip administratiu de 10 personnes.

El 2007 el Departament va assolir fites molt importants. Primer de tot, el Departament va aconseguir un notable èxit en les convocatòries per demanar les subvencions del Consell d'Investigació i Recerca europees (ERC) atorgades a joves investigadors.

Va haver-hi més de 9.000 sol·licituds i l'ERC concedia només 300 beques, de les quals només 15 premis eren atorgats a Economia, Demografia i Geografia. Quatre dels investigadors guanyadors de la beca en aquestes categories pertanyen al Departament: dos d'ells, Toni Calvó i Nicola Pavoni, van obtenir el seu doctorat al Departament; Marta Reynal Querol té una beca Ramón i Cajal al Departament i Jan Eeckhout, professor associat de la Universitat de Pennsilvània, va acceptar una oferta del nostre Departament recentment.

En segon lloc, durant el 2007 un terç dels nostres professors permanents han gaudit d'alguna beca d'investigació i recerca (Juan de la Cierva, Ramón y Cajal o ICREA), que els permet compaginar el temps que dediquen a l'ensenyament amb la recerca.

Finalment, aquest any s'han engegat els màsters amb la col·laboració de la Barcelona Graduate School of Economics, una iniciativa conjunta del Departament d'Economia i Empresa de la UPF, el Departament d'Economia de la UAB, el CREI i l'IAE-CSIC.

Pel que fa al tema de publicacions científiques, el nostre Departament continua amb la tendència descrita a l'últim informe dels indicadors d'ISI per a economia, que assenyala que el DEE de la UPF ha assolit l'augment més alt en total de citacions en el camp de l'economia i l'empresa.

## FACULTY

The Department of Economics and Business aims to be and remain among the world's leading research centres in its fields of specialisation. This demands considerable effort in the process of recruiting its faculty and requires a strict policy of promotion.

The process of faculty recruiting starts every year with the announcement of the vacancies in different international media. As a result, the Department received 455 applications in 2007.

To evaluate the applications, committees by fields (macro, micro, finance and business) carry out an initial selection of candidates.

The 57 chosen candidates in 2007 were interviewed either at the Allied Social Science Association (ASSA) Meeting in the United States or during the Spanish Symposium of Economic Analysis.

Among all interviewed candidates, 38 were invited to present seminars in the Department.

Finally, after the candidates were interviewed in a one-to-one basis by a large number of our faculty members, the hiring commission made an offer to the best candidates.

This demanding recruitment process results in a faculty drawn from the best European and American departments.

All professors in tenure positions or in tenure-track positions are Doctors and 68% of them obtained their PhD in non-Spanish universities. Our faculty includes around twenty different nationalities.

The Department also values the figure of adjunct professors, coming from the world of business or politics, as well as visiting faculty, that is, top international professors who spend several months with us, often on a yearly basis.

## PROFESSORAT

El Departament d'Economia i Empresa de la UPF aspira a mantenir-se a la primera línia mundial en la seva especialitat. Això demana un esforç acurat de selecció i de contractació del professorat i una política molt exigent de promoció dels seus professors i investigadors.

El procés de contractació de professors comença anualment amb la publicació a diversos mitjans de tot el món de les places que es volen cobrir. Arran d'aquesta publicació el Departament va rebre 455 sol·licituds al 2007.

Per avaluar-les es formen comissions, segons especialitats (macro, micro, empresa i finances), que fan una primera selecció de candidats.

Els escollits al 2007, 57, van ser entrevisats bé durant la conferència de l'Allied Social Sciences Association (ASSA), als Estats Units, bé al Simposi Espanyol d'Anàlisi Econòmica.

De tots els candidats entrevistats, se'n van convidar 38 a presentar seminaris al Departament. Finalment, un cop escoltat el seminari i entrevistats els candidats per un nombre considerable de professors del Departament, les comissions de contractació van fer ofertes als candidats considerats millors.

Aquest procediment de selecció de professorat dóna com a resultat que el cos facultatiu del Departament d'Economia i Empresa s'hagi format als departaments de les millors universitats d'Europa i dels Estats Units.

Tots els professors amb places permanentes o en vies de permanència són doctors. D'aquests, el 68% ho són per universitats no espanyoles. En el Departament conviven unes vint nacionalitats diferents.

El Departament valora també la figura del professor associat, procedent de l'empresa o de la política; i la del professor convidat, és a dir, de l'acadèmic o de l'investigador del més alt nivell internacional que passa un any sencer amb nosaltres o que passa amb regularitat temporades al Departament (sovint, un trimestre a l'any, tots els anys).

## RESEARCH

The goal of the UPF Department of Economics and Business is to promote high quality research. It is expected that its faculty members publish in the leading international journals, and both hiring and promotion depend crucially on their publishing record.

As a result, the Department consistently appears at the top of the scientific rankings.

No research project can acquire scope and breadth without a potent graduate programme. Our Graduate Programme is part of the Barcelona Graduate School of Economics, a new institution created in agreement with the Graduate Programme in Economics at Universitat Autònoma de Barcelona and other research institutions in Barcelona to build a Graduate Programme at the maximum level of excellence.

Our Graduate Programme is also part of the European Doctoral Programme (EDP), together with the London School of Economics, Bonn University, Delta (Paris), CORE (Louvain), the European University Institute (Florence) and Tel-Aviv University. The EDP's goal is to promote exchanges of graduate students among these leading European universities and offers a joint doctoral degree in economics.

The DEE has also signed exchanged research programmes with USA institutions, such as the Wharton School at the University of Pennsylvania, the California Institute of Technology, the University of Arizona and New York University, and has actively developed contacts with other leading institutions.

The Department includes five research centres: BDRG (Development) CREF (Finance), CREI (Macro), CRES (Health Economics) and LeeX (Experimental Economics) and is part of CREA, a research group that includes the main research centres in Economics located in Catalonia and works closely with GREL (Logistics) and IET (Regional Economics).

## RECERCA

L'objectiu del DEE és promoure la recerca de major qualitat. S'espera dels professors del DEE que publiquin a les millors revistes internacionals, i l'aplicació de la política de provisió de places en vies de permanència (tenure track) o de consolidació del professorat depèn de manera crucial del seu historial de publicacions.

Com a resultat, el Departament apareix sistemàticament a la posició més alta de les llistes de publicacions científiques.

A banda d'això, cap projecte de recerca pot adquirir veritable àmbit i amplitud sense un Programa de Tercer Cicle de qualitat.

El nostre Programa de Tercer Cicle és part de la Barcelona Graduate School of Economics, una nova institució creada juntament amb els programes de tercer cicle del Departament d'Economia de la Universitat Autònoma de Barcelona i altres institucions de recerca de Barcelona per assolir la creació d'un programa de tercer cicle del major grau d'excellència.

El nostre Programa de Tercer Cicle també forma part del Programa de Doctorat Europeu juntament amb la London School of Economics, la Universitat de Bonn, Delta (París), CORE (Lovaina), la Universitat Europea de Florència i la Universitat de Tel-Aviv, que té com a objectiu promoure intercanvis entre estudiants de tercer cicle de les principals universitats europees i oferir un doctorat en economia conjunt.

El Departament també té signats programes d'intercanvi i de recerca amb institucions dels EUA, com la Wharton School de la Universitat de Pennsilvània, o l'Institut de Tecnologia de Califòrnia, la Universitat d'Arizona i la Universitat de Nova York, i ha desenvolupat activament contactes amb altres institucions líders.

El Departament gestiona cinc organismes de recerca propis: BDRG (a Economia del Desenvolupament), CREF (a Finances), CREI (a Macro), CRES (a Economia de la Salut) i LeeX (a Economia Experimental), i forma part del CREA, un grup de recerca que inclou al seu si els centres de recerca més importants en economia a Catalunya i treballa juntament amb el GREL i l'IET.

In addition to its role as the experimental platform for research at our Department, it has organised a number of conferences on experimental topics and holds annually a summer school for doctoral students, professors and researchers specialising in experimental macroeconomics.



### Master's programme (Barcelona GSE)

The Department offers three Master degrees, the MSc, the MAS and the MRes. All courses are taught in English, and demand exclusive, full time dedication.

The MSc is a one-year programme. Those students awarded the MSc degree will have acquired an excellent grounding in their field and sufficient analytical skills to enter the PhD programme or go into a technically demanding job. The MSc Degrees in Economics and in Finance are offered jointly with the Barcelona Graduate School of Economics. The Barcelona GSE also offers in 2007 three new programmes – the MSc in Competition and Market Regulation, the MSc in the Economics of Science and Innovation, and the LLM in Corporate and Public Regulatory Law, which are UPF/UAB joint degrees.

The MAS is a two-year programme. Its first year is in common with the MSc programme and the second year is given over to field specialisation.

The Master's in Research (MRes) is a two-year programme also called the "Official Master's Degree". This programme is geared towards research-oriented students with exceptional grades in economics, econometrics and mathematics, and exceptional credentials.

### Master's programme (Barcelona GSE)

El Master of Science (MSc) és un programa d'un any, d'elevat contingut analític, que permet a l'estudiant que l'acaba desenvolupar amb èxit feines tècnicament exigents o continuar en programes de doctorat de primer nivell mundial.

El Master of Advanced Studies (MAS) és un programa semblant a l'MSc, però la seva durada és de dos anys, i els requisits són de divuit cursos en total, dels quals tres es poden substituir per un treball de recerca. La finalitat del programa del MAS és especialitzar encara més els estudiants que ja tinguin una idea clara del sector on voldran treballar.

L'admissió als programes segueix un procediment de selecció estricta, que té el propòsit de configurar cada any un grup de cinquanta a seixanta estudiants amb la millor preparació i motivació, d'entre uns dos-cents cinquanta sol·licitants d'arreu del món.

Els programes tenen l'anglès com a idioma únic i requereixen dedicació exclusiva.

La procedència dels estudiants és molt variada. Més del 90% procedeixen de fora d'Espanya, principalment de la Unió Europea, de l'Europa de l'Est i de l'Amèrica Llatina.

Dels estudiants que acaben l'MSc o el MAS, entre dues terceres i tres quartes parts continuen en programes de doctorat, bé a la UPF, bé en altres universitats. La resta s'incorporen al món laboral, principalment en empreses d'assessoria, departaments de recerca, institucions financeres, organismes governamentals o organitzacions internacionals.

The programme is designed to be completed in four years. All courses are taught in English, and demand exclusive, full time dedication.

The PhD Programme is structured in two cycles: The first consists of courses aimed at gaining skills in a wide range of areas, and the second emphasizes active research.

During the first cycle, the advanced level courses must be passed, and during the second cycle, students carry out research together with participating actively in Department seminars and workshops.

The main quality of the programme is its international scope:

**Interaction with other programmes:** The GPEFM is a member of the European Doctoral Programme (EDP). This network was initiated by Bonn University (Germany), the London School of Economics (United Kingdom) and the Centre for Operations Research and Econometrics-CORE (Centre de Recerca de la Universitat Catòlica de Lovaina, Bèlgica). Posteriorment s'hi van incorporar Delta (l'Institut de Recerca de l'École des Hautes Études en Sciences Sociales de París) i des de 1997 la Universitat Pompeu Fabra. La Universitat de Tel-Aviv també en forma part, com a membre associat. Els estudiants d'aquest programa han de passar un any acadèmic sencer en una altra institució membre. Tant el Ministeri d'Educació i Cultura com la Unió Europea han reconegut i han finançat el GPEFM i l'EDP com a centres d'excel·lència.

**Doctorat**

L'objectiu del programa de doctorat en Economia i Empresa de la Universitat Pompeu Fabra és la formació d'economistes amb capacitats superiors per a la recerca i la innovació en totes les àrees de l'anàlisi econòmica. El programa té una durada prevista de quatre anys. Encara que la formació té un perfil acadèmic, els doctors també troben sortides professionals en el món dels negocis, el sector públic o els organismes internacionals. El programa té l'anglès com a idioma únic i exigeix als estudiants una dedicació exclusiva. El programa de doctorat s'estructura en dos cicles: un primer cicle de formació i un segon cicle de recerca. Durant el primer cicle s'han de superar els cursos de nivell avançat i en el segon cicle es desenvolupa la recerca i la participació activa en els seminaris i workshops del Departament. El tret fonamental del programa és la seva decidida ambició internacional, que es manifesta en:

**Les relacions amb altres programes.** El GPEFM és membre del European Doctoral Program (EDP). Aquesta xarxa va ser iniciada per la Universitat de Bonn (Alemanya), la London School of Economics (Regne Unit) i el Centre for Operations Research and Econometrics-CORE (Centre de Recerca de la Universitat Catòlica de Lovaina, Bèlgica). Posteriorment s'hi van incorporar Delta (l'Institut de Recerca de l'École des Hautes Études en Sciences Sociales de París) i des de 1997 la Universitat Pompeu Fabra. Ministry of Education as well as the European Union have recognized the GPEFM and the EDP as institutions of excellence.

**Professional Careers:** It is a departmental rule not to employ its own doctoral graduates. GPEFM PhD graduates have found employment in many different fields. Some of them have obtained postdoctoral grants with prestigious universities such as Tilburg, Oxford, Harvard or Caltech. But the majority has been hired in tenure-track positions in Spain (Carlos III de Madrid, Autònoma de Barcelona, Pública de Navarra, Alacant or Vigo), Europe (ICER in Torí, Humboldt in Berlin, Bocconi in Milan, Nova da Lisboa, Southampton, University College London, Lausanne, Mannheim, or the London School of Economics); Latin America (UNAM or ITAM in Mexico), the United States (SU NY at Stony Brook, Duke, UCLA, San Diego and Yale).

Others have decided to take jobs in the public or private sector (Deutsche Bank, Portuguese Bank, European Central Bank in Frankfurt, Maxwell Stamp PLC in London, International Monetary Fund in Washington, or Lexecon in London).

**El professorat.** Gairebé tots els professors del GPEFM han obtingut el seu títol de doctor en universitats de prestigi internacional.

**Les sortides professionals.** El Departament té com a norma no contractar com a professors els seus propis doctors. Els doctors del GPEFM han trobat feines molt diverses. Alguns han obtingut beques postdoctorals en universitats de prestigi com Tilburg, Oxford o Harvard. La majoria han aconseguit places de professor en vies de permanència a Espanya (Carlos III de Madrid, Autònoma de Barcelona, Pública de Navarra, Alacant o Vigo); Europa (ICER a Torí, Humboldt a Berlín, Bocconi a Milà, Nova da Lisboa, Southampton, University College de Londres, Lausana, Mannheim o London School of Economics); l'Amèrica Llatina (UNAM o ITAM a Mèxic) o els Estats Units (State University of New York at Stony Brook, Duke i Yale). Altres han optat per treballs professionals en el sector públic o privat (Deutsche Bank, Banco de Portugal, European Central Bank a Frankfurt, Maxwell Stamp PLC a Londres, Fons Monetari Internacional a Washington, Lexecon a Londres, etc.).


