





2017 IN REVIEW

This report summarizes the research activities, news and trends of the Department of Economics and Business at Universitat Pompeu Fabra (UPF) during the year 2017. Our Department is a large organization with a research and teaching staff of 316 faculty, 114 of which are full-time professors. We also have a very committed administration staff, a group formed by 13 people.

During 2017 a number of the Department faculty members received Research Fellowships and Research Professorships of various types, allowing them to reduce their teaching load and providing them with additional research funds. In particular, Julian di Giovanni, Libertad Gonzalez and Gaël Le Mens obtained each an ERC Consolidator grant, Ruben Durante and Antonio Penta obtained each an ERC Starting Grant, and Miguel Espinosa was awarded a Marie Curie grant. Ramón y Cajal positions were awarded to Sandro Shelegia, Larbi Alaoui and Davide Debortoli, and Juan de la Cierva grants to Alexander Frug and Geert Mester. Furthermore, we are pleased to mention the successful participation of Piotr Zwiernik and Ruben Durante for Beatriu de Pinós research fellowships.

During 2017, a total of 46 full-time professors of the Department held an individual Research Fellowship/Professorship. This represents around 40% of all fulltime professors. We hired 1 senior faculty: Antonio Penta (PhD University of Pennsylvania) joined us from the University of Wisconsin-Madison and three junior faculty: Jesica de Armas (PhD Universidad de La Laguna), Miguel Espinosa (PhD from LSE) and Alberto Santini (PhD from University of Bologna) and had 3 visiting researchers Angel Luis Gonzalez (PhD UB), Mohammad Ghaderi (PhD ESADE) and Peter Wardley (PhD Wales UC).

The 2017 job market was, as always, quite intense. We received 938 applications and flew out 27 candidates. As usual, we had a busy schedule of seminars and conferences. The Department organized 225 seminars during 2017, which amounts to around 4 seminars per week. We would also like to mention that we had 11 PhD students in the job market who found jobs, amongst others at Harvard University, the Environmental Defense Fund NY, George Washington University and the University of Gothenburg.

Durant el 2016, diferents membres del professorat del Departament han rebut càtedres i ajuts de recerca de diversa índole, la qual cosa els ha permès de reduir la docència i gaudir de fons addicionals per a la recerca.

Cal destacar especialment en Julian de Giovanni, la Libertad Gonzalez i en Gaël Le Mens que van obtenir una Consolidator Grant a ERC cadascun, i En Miguel Espinosa una beca Marie Curie. Les places Ramon y Cajal varen ser adjudicades a Sandro Shelegia, Larbi Alaoui i Davide Debortoli. D'altra banda, les beques Juan de la Cierva han estat per Alexander Frug i Geert Mester. També ens complau informar-vos de l'exitosa participació de Piotr Zwiernik i Ruben Durante per a una beca Beatriu de Pinós a l'AGAUR.

Al llarg del 2017, un total de 46 professors a temps complet del Departament han gaudit d'un ajut/càtedra de recerca. Això representa al voltant del 40% del conjunt de professors a temps complet.

El Departament va contractar l'investigador sénior Antonio Penta (PhD University of Pennsylvania) que es va incorporar al nostre equip provinent de la University of Wisconsin-Madison i tres professors junior: Jesica de Armas (PhD Universidad de La Laguna), Miguel Espinosa (PhD from LSE) i Alberto Santini (PhD from University of Bologna); també va acollir a tres professors visitants Angel Luis Gonzalez (PhD UB), Mohammad Ghaderi (PhD ESADE) i Peter Wardley (PhD Wales UC).

El Job Market del 2017 ha estat, com sempre, molt intens. Hem rebut 938 sol·licituds i hem entrevistat personalment 27 candidats. Com és habitual, hem tingut una agenda replena de seminaris i conferències. El Departament ha organitzat 225 seminaris durant el 2017, la qual cosa significa uns 4 seminaris per setmana. També voldríem esmentar que hem aportat 11 estudiants de doctorat al Job Market i van trobar feina, entre d'altres llocs, a Harvard University, al Environmental Defense Fund NY, a la George Washington University i a la University of Gothenburg.

CURRENT RESEARCH

The goal of the UPF Department of Economics and Business is to promote high quality research. It is expected that its faculty members publish in the leading international journals, and both hiring and promotion depend crucially on the publishing record. The long list of 2017 publications and forthcoming papers, listed in the corresponding section of this report, is the reflection of the importance that the Department places in high quality research.

The Barcelona Graduate School of Economics has recently been ranked by RePEc among the top 17 Economics Departments in the world, the top 5 in Europe and the top one in Spain.

No research oriented department can acquire scope and breadth without a potent graduate programme.

Our Masters in Economics and in Finance are part of the Barcelona Graduate School of Economics.

Our Graduate Programme is a partner in the European Doctoral Program in Quantitative Economics which aims to promote the exchange of doctoral students between the following universities: the London School of Economics, the European University Institute (Florence), the Université Catholique de Louvain, the Paris School of Economics and the Universität Bonn.

The Department includes four research centres: BE-SLab: Behavioral Sciences Laboratory (Experimental Economics), BCBS (Barcelona Center for Banking Studies), CRES (Health Economics) and BARG (Business Analytics Research Group), it has close connections with CREI (Macro and International Economics) and is part of the Barcelona GSE, as well as of IPEG (Institute of Political Economy and Governance).

RECERCA EN CURS

L'objectiu del Departament és promoure la recerca de més alta qualitat. S'espera dels seus professors que publiquin a les millors revistes internacionals, en tant que l'aplicació de la política de provisió de places en vies de permanència (tenure track) i la de consolidació del professorat depèn de manera crucial del seu historial de publicacions. La llarga llista del 2017 de publicacions i d'articles acceptats que apareixen a les seccions corresponents d'aquesta memòria és el reflex de la importància que el Departament dóna a la investigació d'alt nivell.

La Barcelona Graduate School of Economics ha estat recentment classificada pel RePEc entre els primers 17 millors departaments d'economia al món, els 5 principals dels quals són a Europa i aquest el primer d'Espanya.

A banda d'això, cap departament orientat a la recerca pot assolir la seva plenitud sense un programa de postgrau de qualitat. Els nostres màsters d'Economia i Finances són part de la Barcelona Graduate School of Economics.

El nostre Programa de Postgrau és un soci en el Programa de Doctorat Europeu en Economia Quantitativa que té com a objectiu promoure l'intercanvi d'estudiants de doctorat entre les universitats següents: la London School of Economics, l'Institut Universitari Europeu de Florència, la Universitat Catòlica de Lovaina, la Paris School of Economics and la Universitat de Bonn.

El Departament gestiona quatre organismes de recerca propis: BESLab: Behavioral Sciences Laboratory (Economia Experimental), BCBS (Finances), CRES (Economia de la Salut) i BARG (Business Analytics Research Group), té estretes relacions amb el CREI (Macro i Economia Internacional) i forma part de la Barcelona GSE, així com de l'IPEG (Institute for Political Economy and Governance).

RESEARCH CENTRES ORGANISMES DE RECERCA



Behavioral Sciences Laboratory

The Behavioral Sciences Laboratory (BESLab) was created in 2014 as a joint effort involving the merging of the first experimental economics laboratory in Spain, LeeX, the experimental lab of the Department of Economics and Business and the Department of Political and Social Sciences laboratory. This new interdisciplinary laboratory brings together researchers from psychology, experimental economics, marketing science, political science, sociology, neuroscience and other relevant fields. In addition to its role as the experimental platform for research, the BESLab hosts a number of conferences on experiment-based approaches and methods. It holds annually a summer school for doctoral students, and workshops for researchers specializing in experimental macroeconomics. The laboratory and the different software platforms managed by the BESLAB are also used for (in-class) experiments in the undergraduate, master, and graduate programs run by the department.

GRADUATE PROGRAMMES

Master Programmes

These are one-year programmes. Those students awarded the Master degree will have acquired an excellent grounding in their field and sufficient analytical skills to enter a PhD programme or go into a technically demanding job. The Department offers Master Degrees in Economics, in Finance and also in Management. The first two are managed by the Barcelona GSE and the latter by the Barcelona School of Management.

About 90% of the students enrolled in our Master are foreigners.

Doctoral Track

The MRes is a one-year research master that prepares students for entry to the PhD programme. The purpose of the PhD degree programme is to prepare exceptionally talented students for careers in research and teaching at the world's leading academic institutions, research centres, consulting or financial firms, and international organisations. Students are encouraged to pursue their own research interests from the first year to the completion of their thesis.

The PhD programme is designed to be completed in three years. It is conducted in English and requires full time commitment. Whereas no coursework is required, students may take some courses if needed. The emphasis is on active research.

Interaction with other programmes

The Department is a member of the European Doctoral Programme (EDP). This network includes Bonn University (Germany), the London School of Economics (United Kingdom), the Centre for Operations Research and Econometrics, CORE (Research centre of the Université Catholique de Louvain, Belgium), Delta (Research Centre of L'École des Hautes Études en Sciences Sociales in Paris), the European University Institute (Florence), and the Pompeu Fabra University. Tel Aviv University is also an associate member. The students of this programme have to spend one academic year in another member institution.



The ENAIRE Foundation Awards were created in 1995 to stimulate dedication to aeronautics and to award annual research prizes to those deserving public recognition.

The awarded paper, titled "A multi-start randomized heuristics for real-life crew rostering problems in airlines with work-balancing goals", describes an algorithm designed to capture realistic constraints, regulations, and industry rules in order to distribute airline crew workloads in fair and unstressful ways.

Ruben Durante and Piotr Zwiernik awarded Beatriu de Pinós research fellowships.

Profs. Ruben Durante and Piotr Zwiernik of the Department of Economics and Business have been named Beatriu de Pinós research fellows by the government of Catalonia. Awarded researchers are granted €92,000 for salary costs and training expenses for two years in order to train and conduct research at Catalan institutions.

ERC Starting Grants awarded to Profs. Ruben Durante and Antonio Penta.

The UPF Department of Economics and Business is excited to announce that two Economics professors have been awarded European research funding. Profs. Ruben Durante and Antonio Penta have each won European Research Council (ERC) Starting Grants in order to establish research teams and to conduct projects that can last up to five years.

Prof. Durante's ERC project is titled "Independence and quality of mass Media in the InteRnet AGE (MIRAGE)", and will focus on how the Internet has transformed the way of producing and disseminating news, both directly and through its influence on traditional media. He will also study the effect that the network has had on media independence and the quality of content.

Prof. Penta will lead an ERC project titled "Strategic Uncertainty in Economic Environments and Digital Marketing Agencies", to be undertaken in three parts: study of the interactions between the incentives, cognitive abilities, and strategic behaviour of individuals; study strategic uncertainty problems in economic environments and situations of social interaction; and study the impact of the diffusion of digital marketing agencies and auctioning formats used to sell advertising space online, a booming system used by large multinational corporations.

Prof. Espinosa's winning paper, titled "Sourcing of Expertise and the Boundaries of the Firm: The Case of Lobbyists", analyses the roles of knowledge workers and firms' hiring practices. Using the theoretical framework developed by Luis Garicano and the specific case of the US lobbying industry, Prof. Espinosa found that firms hire knowledge workers internally (e.g., lobbyists, IT workers, managers, lawyers, etc.) when the tasks that firms face are frequent, require low levels of skills, or when the client-specific knowledge required to solve these tasks is high.

DECEMBER

CRES-UPF research team wins 2017 Senior Citizen Award from the Agrupación Foundation.

The UPF's Centre de Recerca en Economia i Salut (CRES) (Center for Research in Economics and Health) has won the Agrupación Foundation's 2017 Senior Citizen Award in order to drive young researchers in developing novel aging study research projects.

The prize was presented to the CRES-UPF economics team formed by Helena Hernandez (PhD GPEFM 2017, principal researcher), Prof. Guillem López Casasnovas, and Prof. Catia Nicodemo. All three team members specialise in research on health economics, public economics, and the economics of social policy.

ERC Consolidator Grants awarded to Prof. Libertad González and Prof. Gaël Le Mens.

The UPF Department of Economics and Business is pleased to announce that two professors have been awarded prestigious Consolidator Grants from the European Research Council (ERC). Prof. Libertad González and Prof. Gaël Le Mens were each selected to receive European Union Horizon 2020 funding to carry out five-year Social Sciences and Humanities research projects starting in 2018.

Prof. González will conduct a project titled "The Causal Effect of Public Policy and Income on Child Health and Human Capita". The research project will study public policy shocks and impacts, particularly focusing on child development and the formative years between infancy and adulthood.

Prof. Le Mens will conduct a project titled "The Implications of Selective Information Sampling for Individual and Collective Judgments" that will study the mechanisms that lead to the polarisation of attitudes in social groups. The work will aim to predict the mechanisms of collective decision-making and to explain the role of social networks in providing information.

Industrial (JEI) celebrades el setembre. El JEI és una reunió anual d'investigadors que treballen sobre economia industrial, que serveix per presentar i discutir els seus treballs. El premi s'atorga a papers excepcionalment originals i d'alta qualitat seleccionats pel comitè científic del JEI, i escrits per investigadors que hagin completat el seu doctorat dins dels últims cinc anys.
