





## Project: Monitoring xenophobic political discourses: a pilot study in Catalonia

**Researchers**: Ricard Zapata-Barrero and Gema Rubio-Carbonero.

**Summary**: The purpose of this project is to construct a heuristic framework to monitor xenophobic discourses. As a pilot study it is aimed to make it reproducible in other territories. With the construction of this tool and its application the objective is to identify and counter whatever tendency of political parties of radicalising their position towards xenophobia and racism. This is an especially urgent task to do in times of crisis, which is a favourable context for xenophobia and racism. In order to do so, we take as departure point the theoretical framework proposed by Zapata-Barrero (2009, 2012) with the aim to make it operative. It also intends to strengthen the argument appearing in 2012 that xenophobia is a political construction rather than a social fact in Spain (and Catalonia)
