### *Animal Ethics Review*

Animal Ethics Review (AER) is a peer-reviewed, open-access, multidisciplinary journal published by the UPF-Centre for Animal Ethics. Its aim is to encourage a non-speciesist academic approach to the various forms of discrimination, oppression and abuse against animals, including, among others, farmed animals, animals used for experimentation or entertainment, urban animals and animals living in nature. The journal publishes both empirical and theoretical works from all the disciplines in humanities, legal scholarship, and the social and natural sciences.

Scope: animal ethics, critical animal studies, non-speciesist studies, vegan studies

## INSTRUCTIONS FOR AUTHORS

### **Extension**

The article will have a minimum of 2.500 words and a maximum of 5.000

### **Structure**

The structure of the article should be organized through numbering levels, with a maximum of two sublevels and the references in the end without number. *For example:*

**1. Level 1**

*1.1. Level 2*

**References**

## **Typeface and Spacing**

The article should use the typeface Times or Times New Roman (size 14 for title and 12 for body text).

All the text must use 1.0 line spacing (single-space) and justified with 12 points spacing among paragraphs (no manual leaps).

## **Citation Style and References**

The citation will be done using the Author-Date Chicago format, which you can find in the following link: [https://www.chicagomanualofstyle.org/tools\\_citationguide/citation-guide-2.htm](https://www.chicagomanualofstyle.org/tools_citationguide/citation-guide-2.htm)

In case of using notes, footnotes will be used instead of final notes.

Every paper should include its own list of references at the end of the chapter.

In the reference section, please do not use dashes when the author's name is repeated; instead, use the full name.

## **Spelling and style**

Every paper should start with a 200-250 word abstract and 6 to 10 keywords.

The main title can include a main title and subtitle. *For example:* Every Twelve Seconds. Industrialized Slaughter and the Politics of Sight.

The sections within the text can include a brief subtitle. *For example:* Non-human animal-inclusive climate advocacy: The importance of visual campaigns.

## **Punctuation, quotes, commas, etc.**

Do not add end punctuation to titles or subtitles.

When quoting, please use double quotes. *For example:* They coined the concept "colonial/modern world-system" (Wallerstein & Quijano 1992, 549-59).

Within quote marks, please use single quotes. *For example:* "Images are catalysts for 'the unfolding of compassion'". (Jenni 2005, 6).

Use punctuation outside the quotes.

Do not use serial commas. *For example:* ideological, cultural and political.

## **Numbers**

Spell out numbers through ten and numbers at the beginning of sentences; Arabic numerals for numbers beyond ten.

## **Lists**

For numbered lists, capital first letter and punctuation at the end. For lists with letters, capital first letter, no punctuation at the end.
