## About the event

The next 20th and 21st of September the 1st Spanish ESS Congress on “Spanish Society in Comparative Perspective: 15 years of ESS in Spain” will be celebrated in Madrid at the **Getafe Campus of the Universidad Carlos III Madrid**. The **European Social Survey (ESS)** is an academically driven cross-national survey that has been conducted across Europe since its establishment. Every two years, face-to-face interviews are conducted with newly selected cross-sectional samples. The survey measures the attitudes, beliefs and behavioural patterns of diverse populations in more than thirty nations following rigorous methodological standards. Spain is one of the few countries that have participated across all eight rounds contributing to the development of this international research programme since 2002.

The first Congress in Spain of ESS data users on “Spanish Society in Comparative Perspective: 15 years of ESS in Spain” is organized by the Spanish National Committee of the European Social Survey (ESS) in collaboration with the D-Lab (Discrimination & Inequality Lab) of the Universidad Carlos III Madrid *Centro de Investigaciones Sociológicas* (CIS) and the Research and Expertise Centre for Survey Methodology (RECSM) at the Universitat Pompeu Fabra (UPF). The Congress is funded by the ESS-SUSTAIN project (Horizon 2020, Grant Agreement 676166).

The purpose of the Congress is to bring together ESS data users from Spain and abroad working across a range of disciplines to share ideas, discuss results and show the type of research that can be carried out through the ESS touching upon some relevant topics related to political behaviour and attitudes, social structure and social processes, gender, society and politics as well as survey methodology.

The Congress will officially start with an Inaugural plenary to welcome participants introducing the ESS with a brief overview of the results of the 8th round in Spain in comparative perspective (both from the cross-national and longitudinal standpoints). Before the plenary session there will also be the possibility to participate in a Workshop in which main available online tools to access ESS information will be presented (among which a new R package called “esssurvey”).


