1. Name and introduction to the subject:

The Foundations of Immigration Policies

(Master in Immigration Management)

Diversity and Immigration Policies

(Master in Current Democracies)

The basic objective of this course is to introduce the main foundational debates related to two policy frameworks: Migration policies and Diversity policies. We will focus on immigration as a factor influencing current social, political and cultural change. Particular interest will be placed on identifying/discussing the main issues and dilemma that must be addressed in the liberal democratic context, related to the current social and political agenda. To introduce key dimensions underpinning immigration policies is an opportunity for students to identify the basic requirements of policy innovation and structural change. From a methodological point of view we will follow applied political theory and two main approaches: normative and interpretative approaches.

2. Prerequisites

- General knowledge of immigration trends and policies
- Understanding of implications of immigration in the social and political arena
- Ability to work both from a problem-driven and a theory-driven focus.
- Ability to work interdisciplinary: mainly, political science, sociology, anthropology, law, psychology, and pedagogy.

5. Organisation/plan of sessions

Lecture sessions: the main purpose is to frame theoretically a particular topic/discussion within a particular debate. There will have one introductory session, four sessions related to migration policies, four sessions related to diversity policies

Seminar sessions: the purpose is to enter in a particular debate deepening some aspects of the Lecture session. This activity will be organised by at least two students, who will select each one a reading among the compulsory ones [readings at the beginning of the list, with (*)]. Participations of other students will be appreciated during the session and will be one of the main evaluative moments.

The first day we will Plan a schedule with at least two students that will have the task to prepare the *Seminar Session* (not more than 10/15 mns). The selection of readings will be previously accepted by the professor and communicated to all, for their own preparation.

We advice the student to look before at the structure of the reading (how the author structure information), and then at the content. To prepare and deliver a Power Point to the professor is compulsory.

Note concerning deliveries of Seminar Sessions: if they are already full, as alternative, two critical reviews of two articles/chapters of the Teaching Plan previously agreed with the professor) (max. 4 pages per chapter/article), following the same rules than the seminar discussion. No reviews related to readings worked in the seminar sessions will be accepted.

Tutorial sessions: The whole Tutorial session will be devoted to discuss and follow the WP work-in-progress.

- Main WP requirements:
 - The WP is individual
 - Length of the WP: between 5 000 and 6 000 words (bibliography and notes included) [WP exceeding this length will be not accepted]
 - Deadline (**not negotiable**): **8 January 2016**

Main framework to organise Tutorial sessions: apart from the 8 tutorials sessions, each student have to go at least two times (date optional) to meet the professor for a face-to-face meeting. It is compulsory to come with one page of contents duly identified. The tutorial sessions will be collective, and devoted to one part of the WP as indicated in the Contents (section 4) and in the following section

Main objective and focus of the WP: to draw an interpretative framework and conceptual map of a particular conflict

- The main focus is that the student Theorises an empirical problem/conflict
