## Description of tasks to be performed:

- 1. Active participation in the research activities conducted within the projects.
- 2. Work with the researchers part of these projects on the design, development and testing of the proof of concepts, empirical research and data analysis within the content and goals of these projects.
- 3. Support in the research activities, research, drafting and writing research on the research conducted within these projects.
- 4. Presentation of the research results obtained at workshops and conferences at the Department of Law Universitat Pompeu Fabra and eventually in other academic institutions.

# • Candidate requirements:

- 1. Good command of Python with demonstrated coding experience.
- 2. Experience with other programming languages, such as R and Julia.
- 3. Experience with machine learning and language models.
- 4. Experience setting up and working with virtual machines, including using Docker.
- 5. Experience with web scraping.
- 6. Experience with browser automation using tools like Playwright
- 7. Knowledge of information extraction and text classification.
- 8. Research and writing skills in English Spanish a plus.

#### Criteria for the assessment of candidates:

Applications will be accepted until 31st March 2024 and only complete applications will be considered. If needed, this date will be extended<sup>1</sup>.

It would be an advantage if the candidate has a Spain work and residence permit, due to the emergency recruitment situation. The applications of women and minorities are particularly welcome.
